related? The CRI Perspective in a moment. What is Reasonable Faith? Biblical faith is not a blind faith but is, in fact, faith in evidence. First of all, the Bible is very clear that faith is based on truth. God's Word is Truth (John 17:17), and God cannot lie, or contradict this Truth (Titus 1:2). Thus, the whole Bible presupposes the validity of reason.
